Tuesday, September 20, 2022

The September 20, 2022 meeting of the Munhall Borough Council was called to Executive Session by Mr. Brennan at 6:53 pm in the executive conference room to discuss personnel and real estate matters.

Reports

President's Report: Mr. Brennan reported that the Enterprise Zone is looking to reorganize and rebrand.

Mayor's Report: Mr. Falce spoke about the upcoming Community Day on October 1, 2022 and stated that volunteers are needed.

Solicitor's Report: The employee handbook has been reviewed with recommendations made to the Borough Manager.

Borough Manager's Report: On file. Mr. Abrams reported that he has worked with the engineer to put together a plan to camera and evaluate the storm sewer pipes in five designated "hot" zones beginning with Main St due to grant funds already being available, and to be immediately followed by the Shady Ave area. After the camera work is completed with flow studies further plans can be developed off of those results.

Engineer's Report: Ms. Dumm reported that the paving of Raymond Bodnar Way is well under way and that the MS4 application to PA DEP will be completed, signed by the Manager and submitted by September 30, 2022.

Public Works Report: Mr. Bicsey reported that in addition to the reported activities the crews have been doing a significant amount of hot patching on the roads. Mr. Ondo reminded the public that there is a 50lb weight limit on trash cans. He has observed cans that are overloaded in the parks and cans that are filled with water in the alleyways. The weight of these cans pose a danger to the sanitation crew. Residents were also reminded that the Borough dumpsters at the parks are not for the personal disposal of construction materials.

Police Report: Chief Fullard reported on arrests. There have been four concerts held at the Carnegie Library of Homestead since the beginning of September. None have resulted in resident complaints regarding parking, nor were any violations observed.

Fire Department Report: Chief Pletsch reported that he attended the FMI training in North Carolina. The Fire Department did respond to 3 significant fires including ne involving solar panels, and one on Longfellow Dr. Pets were involved in one fire and the responders were able to perform CPR and resuscitate at least 2 of the animals. Chief Pletsch noted that his term expires on December 31, 2022.

Code Enforcement: Mr. Cannon reported on his activities for the month. His report is on file. PA DEP has given the go ahead for the construction of the Checker's/Rally's restaurant on 8th Ave.

Finance Committee: Mr. Hanna reported that there is a current forecast to run a surplus for the remainder of the year if the RAC-P grant funds are deposited by the middle of December. The RAC-P grant for the Borough building is still awaiting final paperwork before the funds are released. Budget meetings will begin in October

Sewer Authority: Mr. Younkins reported that the Sewer Authority's new building is undergoing the required renovations.

Motion to approve Meeting Minutes: Mr. Votedian made a motion to accept the August 16, 2022 meeting minutes as presented. Mr. Ondo seconded. Motion passed unanimously.
