Solicitor – Reviewed proposed agreement for Optimus Risk Services and no changes are necessary. Reviewed nuisance ordinance. Discussed Sherriff sale process with Council.

Manager – Discussed proposals for copier service and Engineer for 2016. Also have to discuss and make a decision about Drug & Alcohol Company. Getting cost from third party for time clocks for employees. Contract expiration with Turnkey. They are working with Dave Cannon on Database for Rental Listing. We are doing well with collection of Local Earned Income Tax via Jordan Tax Service.
