Other Matter(s):

Mayor Brennan asked if current board/committee members, who's times are expired, must reapply or do we just check to see if they want to renew. Per Borough Manager Joe Varhola, they need to send a letter of intent.

President Falce asked if the alternates are expired for the Civil Service committee. Joe Varhola advised he will check in to it.

Councilman Votedian addressed writer of recent online article regarding the waterfront property with his concerns of how the article was written.

Chief Campbell expressed his concerns as to how his name was brought in to the article and he never spoke to the writer.

President Falce said he was concerned about the light in which the members of Council were portraited. The article didn't say they were dishonest but the play on words left residents believing there was a problem.

Solicitor Evashavik explained the eminent domain process and the acquisition of the Jr. Achievement property (including taxes and conditions).

Mayor Brennan advised it was taken under eminent domain for Parks and Rec use and asked council to get a commercial appraiser to get a proper value of the property. Who would pay for the appraisal? Residents. What would the cost be? Between 6-10 thousand dollars. Mayor Brennan asked Council for their blessing to continue looking for funding to develop the Jr. Achievement property as a park. He advised he has already spoken to the Penguins organization and will continue to reach out if Council agrees. Councilman Tichon advised he, and Council, are open to all options.

Councilman Stein explained Jr. Achievment owed approximately \$70,000 in back taxes and he questioned if the land were truly worth at least the assessed value of \$265K why didn't JA opt to sell the land instead of giving it away.

Resident Scott Stevens asked about possible solar panels. Joe Varhola advised leasing the property is always an option.
