3. Robert Kalan, 2410 Charles Street, Munhall

- What is the amount of the payments to the police pension and public work pension and is that why the budget is short. Also heard a rumor that there is \$200,000 owed to social security that was taken out of paychecks but not forwarded to social security.
 - Manager Little replied that both pension plans have been made whole. Any interest and penalties have been whole as of September. After speaking with the Social Security Administration, the problem is a reporting problem. If money wasn't submitted there would be more notifications to the borough office. W2's from 2011 have not been submitted to the Social Security Administration. That is way they have not posted for individuals employees.
- Robert Kalan questioned why the computer was removed and why was it gone for a week.
 - Manger Little replied that everyone had reservations • about the computer leaving the office on July 23, 2013. Mr. Galla left a packet of an outside payroll company. A packet was given to that payroll company with payroll report of the first two quarters of this year. Mr. Galla printed out a report on June 17, his last day and the last payroll for the second quarter was June 23. It did not capture that last payroll report. Paytime didn't know that. A week later, Paytime said there was a missing payroll report and they needed it. They needed that payroll for liabilities reasons because they need a payroll for a whole year for W2. Coming to the last week in July, Paytime informed Mr. Little that if they didn't have the payroll report by July 26, they would cease being the Borough's Payroll Company. If The Borough didn't get that report to Paytime, employees' would not get paid. Many people tried to get ahold of Mr. Galla with no answer. Councilman Lloyd took the computer to Mr. Galla and received the report to give to Paytime and employees were paid.

County Foresnics aren't able to find any records.

 - Mr. Little replied no. Once we find the 2011 quarterly reports then we will start to build the payroll and get the process started for audits and it will be labor-intensive work.
 - Brian stated when the work is ready to be started to maybe hire additional staff to start working on the reports.

Also wants to say thanks to public works for alerting the Authority to a problem on West Schwab and Walnut St. Some earth has sunk into the around the sanitary lines and after inspection the lines separated and over time water has taken dirt into the sewer line. We will repair it and is only 8ft deep. The update on the Homestead Run/West Mifflin/Whitaker Borough project that now involves the DEP. The Consent Decree has a clause that we would rehabilitate Homestead Run that starts on Brierly Lane and goes to Ravine Street. This clause makes up different from any other municipalities in Allegheny County because no one else has to work on their main interceptors until 2026 due to ALCOSAN not doing any repair work until that time. It was put in our Consent Degree because of the swiller had potential overflow conditions. The DEP was approached and asked to have this Clause removed. DEP replied that the clause was put in because there was a flapper gate at the river that was overflowing in dry weather and the Clause would fix it. Mr. Terrick advised the DEP that it was fixed by cleaning the 18inch line out. The DEP said that we should still repair the line. Mr. Terrick asked why, because ALCOSAN will not be able to accept the additional sewage that will be sent. The meeting was unsuccessful. This project is an \$8million dollar project that will be passed along to the ratepayers. ALCOSAN also has talked about taking over the interceptors and repairing it themselves. Also we are going to have to repair home laterals by 2026. Mr. Terrick recommends repairing upstream because if you can reduce flows, then you won't have to put in a big system that requires an \$8million dollar repair.

- Mr. Terrick advised possibly 50% to 100%.
