Mayor – **Mayor** Brennan thanked Mr. Parnell for his concerns regarding the current building and thanked the residents for their attendance. He commended the police and fire departments for their dedication and diligence regarding the Crawford Street fire. He also recognized the public works department for their service to the borough. Mayor Brennan asked Council if they would be advertising for positions that will be open on the recreation and planning boards. He feels "young people need to be involved." President Falce advised open positions will be advertised. He discussed the Cemetery board, the local courts and their volunteer program. Mark Fallon advised they are still working on the 5013C status.

Solicitor - No report

Manager - His report includes all the items for consideration.

Engineer – Did not receive the grant for Boone Way and Dickson Street. He advised they will pursue it again in 2019. Joe Varhola advised there can be other options as well. Mayor Brennan asked about paving McClure. Joe, Colin Lampark and Mayor Brennan discussed the Borough 5-year plan and the current paving projects for 2018-2019 as well as the bid processes for those projects. Mayor Brennan asked, and Colin advised the Shady Ave project will start soon.

Public Works Supervisor - No report

Police Chief – Report submitted. Thanked Chief Pletsch for his assistance with Crawford Street fire.

Fire Chief – Report submitted. Very busy with recent fires. Thanked Chief Campbell and the police department for their recent assistance with the Crawford Street fire.

Code Enforcement Officer – Report submitted. Asking for a motion to advertise for rezoning on 9th and 10th to B2. Greg Evashavik advised of the process.

VI. Public Comments on Items for Consideration:

Donna Dreshman – Motion #3 – Asked what the amount for the fund will be.

Public Hearing conducted by Solicitor Evashavik. He explained the TIF and the agreement with the other 2 boroughs to maintain the infer structure of the Waterfront. All three municipalities will make decisions, along with the SR COG, on projects that will be done through the fund. He also advised that the area, for Munhall, has been extended to cover the fly over bridge.

Donna Dreshman asked for clarification on how much money each borough will put in to the fund. Greg explained the total amount in the fund will be \$750,000 and that the money for each borough is based on road miles. Munhall's percent is 34.85% and amount will be \$261,375.00. Donna asked for clarification on Waterfront drive and the ramp in Homestead. President Falce advised all three Council Presidents will need to agree on all proposed projects. A resident asked if there are currently monies in the fund. Rob and Greg said yes but they were not 100% sure of the amount. Rob thinks it is around \$300,000. Hearing concluded.

Donna Dreshman – Motion #4 – Have other boroughs voted on this? Per Solicitor Evashavik and Manager Joe Varhola, yes. Munhall is last to vote. Motion #5 – What is this? Manager Varhola explained the program and updating the process for benefit processing. Motion #6 – Is it the whole building? Per Joe yes. What happens to the position that takes care of it currently? Joe advised the public works director will pull them where needed. Motion #7 – What is this? Joe explained the yearly administration fee with the Enterprise Zone. Donna asked if the administrator retired? Joe advised he hasn't gotten notification from anyone. Motion #8 – Is there a copy of the budget? Joe advised he had one on hand and there is one available in the administration office. Donna asked about the breakdown for each department. Joe advised the breakdown is available. She inquired of the amount for the estimated revenue and Joe advised \$9,156,150.00. Motion # 10 and 11 – Is this based off the Civil Service – Greg Evashavik advised yes.
