VII. Reports:

Finance Committee Chair: Councilman Varhola – Report submitted – Had a successful meeting with Bookminders

Ec. Dev./Blight Committee Chair: Councilman Brennan - Spoke with Enterprise Zone and advised of new ED/Blight Committee. Blight Committee is asking to speak with Council and Dave Cannon to possibly locate 5 properties that can be expedited to Sherriff sale. The Mayor and Councilman Brennan discussed 428 8th Ave.

Public Works Committee Chair: Councilman Inglis – Met to discuss the Backhoe. Thanked PW Employees and Supervisor Biscey for job well done through winter.

Public Safety Committee Chair: Councilman Votedian – Discussions of take over of Whitaker PD but no decisions so far. Police contract coming to completion.

Parks/Rec Committee Chair: Councilman Stein – State Grants for park planning. Is matching grant. Also fee structure for Westfield is complete but is work in progress. Asking about who has final decision about how the field is lined. Council President discussed usage of the field and upcoming costs.

Mayor Bodnar: Memorial Day discussions about Homestead Cemetery. Bob Callen advised there is a War Memorial fund. Councilman Brennan advised he will make sure the area around the Memorial is taken care of for the services. Also asking about Cemetery cell tower. Inquiring about motion on the books about the field being called William W. Knight Recreation Park and staying such.

Solicitor Evashick: Homestead Cell Tower – Researched record of deeds and found that there is a ground lease for the ground the tower sits on and being paid at \$1000 per month. Homestead Cemetery owns the land and should be getting the money. But the Homestead Cemetery group is not getting it as there is no Cemetery group. Solicitor advised we are not a party to the agreement and we are not entitled to know who is being paid to. Greg may be able to revisit the contact with SBA to see if they will release the information to us.
