The Tax Increment Financing (TIF) Committee approved the financial support for items #1-#3 below and requests Munhall Council to approve Motions that resulted from the TIF Committee actions:

Move to approve a request by Valley landscaping, a ministry of Eighth 1. Avenue Place, to maintain the tree wells along 7th Avenue to the BP station in West Homestead. The work includes infrastructure/site preparation, lining the tree wells with landscape paper, edging and mulching the tree wells and ongoing maintenance including garbage and weed removal through the end of September. The cost for this effort will be \$1,500.
