- 3. Linda and John Walters –205 Emerson Ave., Munhall. Mr. Walters asked if occupancy permit was issued on 201 Emerson Ave? As of

11/11/13 was not issued. Occupancy was started on 11/8/2013. Mr. Walters recited Chapter 299 of the Municipal Code. Also has a lien letter been filed and the taxes have been paid? As of 11/14 the taxes were not paid. Has this property had the proper inspections? Mr. Walters gave legal notice to council unsafe conditions exists at 201 Emerson Ave. We have a list of health and safety issues that must be addressed. The property omits a foul odor of raw sewage during the summer months. Numerous generations of squirrels and raccoons have filled the attic with nesting material. Many years of dog feces and urine have contaminated the first floor and needs replaced. The dye test was failed and the previous owner installed rain barrels to pass the test however the rain barrels do not drain properly to the street therefore overflow and breed mosquitoes. The foundation is cracked and is failing. The entire addition is separating from the foundation. The fuse box is not up to code. The basement is constantly flooded. There is asbestos on the ductwork and there is a dying sycamore tree in the back vard. Explain to us how a sale can legally take place in this borough with this house in this condition. We expect action taken by the borough to subject the property to proper inspections, seize the occupancy permit and require the delinquent taxes are paid. The citizens are not protected by the code.

Mr. Cannon replied that it was inspected on 10/11/2013 due to the house was being sold. There were two individuals there stating that they were watching the house and are moving out that weekend. There were nine dogs in the house. The house was in deplorable condition. A tempory occupancy permit was issued on 10/25/2013 to the new buyer. The closing date was on 10/31/2013. The week of 11/18/2013 I received a call stating the people moved into the house. I went to the house and there were two elderly men painting the first floor. There was no furniture in the house. I told the owner of the property that he could not move in until he receives an occupancy permit. On 11/25/2013 I received another call stating that furniture was moved in and people are living there. I advised the owners and his son that they cannot move in until they receive an occupancy permit. The owner replied that when work late at night they have crashed there. There were two beds upstairs however no furniture was noted on the first floor. They were advised to place smoke detectors in each bedroom. On 12/16/2013 the house was inspected. My report showed that the following are against code is that the address numbers must be four inches in height; lids have to be on garbage cans, the basement windows need fixed to prevent water from entering the basement. The electrical should be updated, however as long as the right fuses are in place and circuits aren't

overloaded it will be fine. Window frames should be scraped and painted. A guardrail needs placed on the steps going downstairs. Ebony Warren, 201 Emerson St. replied that he went to school for carpentry, there have a few days that we stayed there and didn't move into this home until Dec 8<sup>th</sup>, 2013. The floors were stripped, facets were fixed, all rooms have smoke alarms, and will replace the windows in the basement. We do not live in deplorable conditions. We didn't cause these conditions and we have been fixing the issues that Dave Cannon has stated that needs fixed. We are in the process of fixing everything and want to be outstanding citizens.

Mr. Cannon stated that every window is operable and will look at the foundation. Linda has never called about Emerson until the past two months.

Mr. Walters asked how can a property in this condition sell in Munhall. I have studies showing that this house should have been torn down.

Borough Solicitor Evashavik stated that any property could be sold as is, it is the borough's responsibly to enforce our code, and go after taxes. The borough cannot say no when buying and selling property. Mr. Walters stated that they would be following every step of this process with this property.

4. Patricia Brown – 2718 Homestead Duq. Road has been abandoned, vandalized, and no utilities for ten years. Mr. Evashavik stated that the house was on the demo list and was advised that the demo meeting has been pushed back every month. The Interim Borough Manager at the time stated that the condemnation meeting would be held in January. Is this true?

Manger Little replied yes and it will be on January 16<sup>th</sup>.

- 5. Agnes Hogg mentions that when Richard "FOO" Brennan, Officer Seiss can and stood at the head of the casket for six hours, never smiled, and never talked that day. Same with Officer Smoley. Officer Seiss came back and did it again the next day, without pay. They stood and paid respect to a fellow officer. Chief Campbell had a presentation. I am very proud of the Munhall Police Department and we should honor our police more.
- 6. Marty Lischner talked about having an awareness concert at West Field and will need two police officers and the stage booked by January and is asking for \$500 for the stage that will be paid back. A committee will be formed and will need access to the field. Councilman Votedian wanted to have a motion placed tonight to give Marty \$500.

Councilman Lloyd stated that this is public money and we are not in the position to give you \$500.

Karen Pletch from Woodlawn Ave asked if there could be a process for the community to fill out when there are issues with the Code Enforcement Officer. Dave Cannon stated that it can be put on the website.

Donna Dreshmen from Forest Ave asked if item 2 is a tax increase. Councilman Ballas replied one mill. Donna stated that there will be a new council member in January, and asked if the new council member agreed to not being paid and that line item could show \$2,400 for him due to the fact that what has happened in the last year was not his fault and was not sitting on council. Is the Audit done? Mr. Little replied before June. There is a bookkeeping company coming in to assist with helping with the bookkeeping, also the 941 forms were not submitted with payments to social sercurity. Donna thanked Mr. Little for helping getting the borough back together. Item #19, will there be a pay increase. Mr. Little replied there is none scheduled at this time.

Linda Squires mentioned that she emailed Dave Cannon and had proof that there is raw sewage smell coming from the neighbor's house during the summer. Mr. Ballas advised start with Mike Terrick.

Borough Solicitor: Last month we discussed the on going concern with delinquent properties and vacant properties to get those back on the tax roll. Council has a form for a request to receive \$5000.00 to assist to cover with fees and expenses with sheriff sales. Once it is finalized, council can make a motion to accept it.

Borough Engineer: Council has my report. 2013 paving project is wrapping up. Next month I will provide a report to repave streets. The demo project letters were mail for the hearing next month. During the site visit to the flyover, the damage did not weaken the structure. A study was performed and it is unsafe for large trucks to use the flyover and should be rerouted. Trucks over 40 feet need to re-routed. We are still working on the safe route to schools.

Public Works: Two new trucks came in and council has my report.

Chief of Police: Council has my report. We have had three trucks from the same company wreck on the corner of the fly-over in the past few weeks. Penn DOT is willing to work with us.

Fire Chief: responded to 29 calls with no injuries. The volunteer hours are 550 manhours. This time of year there are more electrical fires due to overloading the circuits, make sure your tree is watered.

Code Enforcement: Council has a copy of my report. Is there going to be a meeting next month for abandoned houses and will be willing to advertise the meeting. Councilman Lloyd advised to set up a meeting however the public should not be involved until the parameters are set.

Mr. Falce stated that no one is a fan of a tax increase. In January the budget can be reopened. By state law we have to pass a budget by the end of the year. Mr. Lloyd stated that the millage rate has gone up 51% since 2008 with no end in sight. The only thing that restricted us is that we lost \$350,000 in RAD money and workers comp increased another \$210,000 in the last two years. We need to control spending. We need to grow our tax base and this is a wrong approach. We have increased our revenue almost 70% and it is still not enough. We need to control our cost. Mr. Votedian stated that he doesn't want to raise taxes but we have to in order to pay for the library. Mr. Shields stated the library increase is only \$60,000 and is the only quality of life we have in Munhall. Families do not move here and families don't want to stay. We do not have parks and the grass is not cut unless we call. This is more than passing a budget. We have to fix it. We have kicked the can down the road long enough. I will walk away with my head held high. We will give the Library \$112,000. It was in the referendum. To blame this on the Library is unfair. Mr. Votedian replied that he is not blaming it on the Library but we have to get the money from somewhere. Mr. Lloyd stated that we are in the top 8 of 135 municipalities in the county and what do we have to show for it. Nothing. Things need fixed.
